The contributions of resettled refugee families don't end with those resettled. The journey and impact, whether on a local or a national level, of those individuals and families continue on for generations and generations to come.

One such example is, Carol Huynh, the first Canadian woman to win an Olympic gold medal in wrestling. Carol was born to parents who were Vietnamese refugees, resettled in the town of New Hazelton, British Columbia, by the local United Church.



## INQUIRIES

### You Asked

**Are the OYW medicals covered by IFH overseas?**

### We Answered

Yes, OYW medicals are covered by IFH.

All Visa offices print and provide IFHP certificates to those resettled refugees overseas who are to be seen for their medical by a non-IOM physician (i.e. mainly the privately sponsored refugees). For those whose medical is performed by an IOM physician, the Visa offices send a list to the IOM Physicians. All resettled refugees eligible for IFHP receive IFHP certificate at POE (no matter if they have received one overseas).

**Nationality:** Myanmar

Myanmar refugees couple with 2 accompanying children. They have experience as farmers. They fear returning to Myanmar as they will be persecuted for leaving the country. They have no family ties in Canada and would appreciate the assistance of a sponsor during their resettlement in Canada.

**PROFILE #: 1144-04-18**

**Nationality:** Syria - The family wish to resettle near the PA's brother in Saskatoon ON.

Large Syrian family of 7 including children between 1 to 13 years old. The PA has significant experience in farming. The family has relatives landed in Saskatoon SK including the PA's brother, and would like to be close to him. The PA and his family are seeking a better life and would appreciate the assistance of a sponsor during their resettlement in Canada.

**PROFILE #: 0971-03-18**

**Nationality:** Syria - The family wish to resettle in Cousin, Saskatoon, SK

Syrian family of four with two children. The PA has experience working as a pickup driver and in construction. The family cannot return to their home country as they fear for their safety. They would benefit from the additional support of a sponsor upon arrival to Canada.

**PROFILE #: 1239-05-18 (URGENT!)**

**Location: No Specific Location (Preferably where there is an Eritrean Community)**

Single 18 year old Eritrean man with no formal education. He was residing with his mother and sisters in Ethiopia in a refugee camp for most of his life. He left Ethiopia to attempt to find a better life, his goal was to cross over to Europe. The PA cannot return to his home country as he fears persecution based on his religion and imputed political opinion. PA doesn't have any relatives in Canada, so he needs support to help him in his daily life and through his transition to new life in Canada.

**PROFILE #: 0385-05-17**

**Location: Vancouver Area**

Syrian family of 6 including 4 children between 5 to 16 years old. The principal applicant is up-to-date with language support, health and housing services, and are well oriented with the city's transportation system. He has 12 years of education and work experience as a baker. 2 children have significant medical conditions, thus the family requires extra support with medical expenses and medical needs. The assistance of a sponsor during the resettlement in Canada will affect the well-being of the family as both parents are extremely preoccupied, and consumed with, the children's medical conditions.
